The launch of the new KDT JU, which will replace the ECSEL JU as main European funding instrument for Electronic Components and Systems, is getting near. The opening of the first call is announced for December 16. There are several innovations with respect to the ECSEL JU: in the modalities of the two calls foreseen for 2021-2022, in the wider scope, including also Silicon Photonics, and in the presence of calls for specific topics.

In order to illustrate the characteristics of the new program, to inform on the funding available and to give visibility on the project proposals under preparation, the ECSEL Mirror Group Italy, with the support of AEIT and the University of Bologna, is organizing on January 26 an information and networking day in Bologna.

Due to the present status of the COVID 19 pandemic, the event will be exclusively online

The program will be dedicated to the KDT calls and the perspectives for the future of EU funding for Electronic Components and Systems in the coming Future Horizon Europe programme. After the presentations by the ECSEL/KDT Office, public authorities, and representatives of industrial institutions, some space will be given to project ideas and partnership opportunities from recent brokerage events, with the participation of other ECSEL Mirror Groups.
